## **DISTRICT MATCH SUBSIDY FORM- MARITIME DISTRICT**

The District Match Subsidy is a church gift matching program, funded by the Maritime District of the PAOC, which will provide students with up to \$450 toward tuition for a Master's Pentecostal Seminary course, matching the amount provided by your home church. The following criteria must be meet:

- Applicant must be accepted into the MTS (Pentecostal Studies) program.
- The home church of the applicant will provide up to \$450, which will be matched by the District.
- If the student's home church is unable to provide any funding, the student can submit The Charles
   Scholarship Fund Application Fund, available at <a href="http://mpseminary.com/scholarships">http://mpseminary.com/scholarships</a> to request
   funding from The Charles Foundation. NOTE: This District Match Subsidy Form can be submitted prior
   to the student receiving notification that they will receive any funding from The Charles Foundation.
- The student must be a pastor or staff member at a PAOC church in the Maritime District.
- The student must include proof of course registration for a PENT-designated course with this form.
- This subsidy is ONLY available once per year. This subsidy will be awarded based on availability of funds.
- Students who receive the **William A. Griffin Scholarship** will not qualify to receive this subsidy for the same course.

## **Steps in the Process:**

- #1. This form to be completed by student and, where necessary, the church representative.
- #2. Mail this form, along with the payment, to the address stated below.
- #3. Email a copy of the form to Master's Seminary at info@mpseminary.com
- #4. Once form is received, Master's will contact the Maritime District on your behalf.
- #5. Once the funds from your home church or Charles foundation, along with the Maritime District are received, then it will be sent directly to your Tyndale Student account. The student will pay the remaining course cost directly to Tyndale Seminary at the time of registration.

Payment from the church can be made **by including with this form a cheque**, payable to "Master's Pentecostal Seminary".
