The Charles Scholarship Fund (“CSF”) is available to applicants enrolled in the MTS in Pentecostal Studies or the Graduate Diploma in Pentecostal Studies, with Master’s Pentecostal Seminary (“MPS”). The Charles Scholarship Fund is available to individuals ministering in or from Francophonie, Maritime Canada and Northern Canadian Communities.

### Requirements for the Charles Scholarship Fund (“CSF”)

1. Individuals presently serving or looking to serve in Canadian communities specifically in Francophonie, Maritime Canada and Northern Canadian Communities.
2. Acceptance into the MTS in Pentecostal Studies or the Graduate Diploma in Pentecostal Studies program, with Master’s Pentecostal Seminary.
3. Submission of a Charles Scholarship Fund Application Form.
4. Open to Canadian, US and International students.
5. The student must include proof of course registration for a PENT-designated course with this form.
6. Subject to availability of funds.

## **Funding Levels Available**

**CSF District Match Assistance:** The Charles Scholarship Fund will provide up to \$450.00 in the place of a church subsidy towards the PAOC (Eastern Ontario, Nunavut and Maritimes) District Match subsidy. The Charles Scholarship acts as the church subsidy in cases where local churches cannot financially support a student. The student must be a Credential Holder or on Pastoral Staff with the PAOC in either the Eastern Ontario and Nunavut District or Maritimes district. This subsidy is ONLY available once per year. (The CSF provides up to \$450, the District matches up to \$450, the student covers the remainder)

### **CSF Match A:**

The CSF will match \$600 for the 1<sup>st</sup> Pentecostal course to students who have qualified for and received the Masters Pentecostal Seminary Entrance scholarship.

### **CSF Match B:**

The CSF will match \$500 for the 2<sup>nd</sup> Pentecostal course to students who have qualified for and received the Masters Pentecostal Seminary James McKnight Continuing Education Scholarship.

### **CSF Subsidy:**

The CSF will provide up to \$500.00 for any subsequent PENT course in a year.
